

Auszug aus dem Lizenzvertrag zwischen **Editorial Projects in Education, Inc. ("EPE")** und dem **Fachinformationsdienst (FID) Bildungsforschung**, vertreten durch die Universitätsbibliothek Erlangen-Nürnberg vom **7.1.2015**

2. Permitted Uses of Licensed Content

- a) Licensee and Institutions may use Licensed Content for its own internal business and educational purposes, but not for commercial exploitation and not in any fashion that provides access to Licensed Content to persons other than Authorized Users.
- b) Licensee and Authorized Users may make all use of Licensed Content as is consistent with the Fair Use Provisions of United States and international law. Nothing in this Agreement is intended to limit in any way whatsoever Licensee's or Authorized User's rights under the Fair Use Provisions of United States or international law to use Licensed Content.
- c) Licensee and Authorized Users may access, download, and reproduce a reasonable number of copies of Licensed Content solely for purposes of research, education, or other non-commercial use during the term of this Agreement. Licensee and Authorized Users may use brief quotations from Licensed Content, provided EPE is acknowledged as the source.
- d) Licensee and Institutions may provide a reasonable number of electronic links to Licensed Content from Licensee's web page(s) for benefit of Authorized Users. Licensee shall make changes in the appearance of such links and/or in statements accompanying such links as reasonably requested by EPE.
- e) The Publisher hereby grants to the Licensee, subject to and in accordance with the terms of this License Agreement, a non-exclusive perpetual (license) right to host the Licensed Content (i.d. PDFs) on Licensee's Local Hosting Server or on the server of a third party, and allows the Institutions to communicate the Licensed Content via a Secure Network to Authorized Users, to allow Authorized Users to access and use the Licensed Content via Secure Authentication.
- f) The Publisher hereby grants to the Licensee and the Institutions subject to and in accordance with the terms and during the term of this License Agreement, a non-exclusive perpetual license for the Metadata and content material associated with the Licensed Content for use in local catalogue systems, regional or nationwide union catalogue systems and such other library services and information systems including but not limited to search engines of the Institutions and third parties. The metadata may be indexed for this purpose and, if necessary, integrated by links into local catalogue systems, regional and nationwide union catalogue systems, other library services and information systems operated by third parties (including, but not limited to, search engines). These links facilitate direct access by the Institutions and Authorized Users to the licensed product and the information objects it contains. All users have the right to use the Metadata in this way.
- g) The Licensed Content or Parts thereof (excluding Ed Week Market Brief, a separate publication from Education Week and edweek.org) may be compiled, indexed and catalogued (including, without limitation, the header data and abstracts) by the Licensee and the Institutions. Anything thereby created or compiled and properly attributed to edweek.org may be integrated into the products and services of the Institutions pertinent to research, archives, coursework/coursepack or other related curricula. Metadata may be integrated into local catalogue systems, regional or nationwide union catalogue systems, other library and information systems operated by third parties (including but not limited to search engines of commercial corporations provided that the Metadata is not sold, lent, re-licensed, or distributed in any manner that violates the terms and conditions of the licence).

3. Prohibited Uses of Licensed Content

Except as expressly permitted in this Agreement, Licensed Content may not be used in any form or medium. Neither Licensee nor any Authorized User may decompile, reverse engineer, or disassemble the Web Site or Licensed Content. Systematic or programmatic downloading or printing of Licensed Content (e.g., downloading or printing entire issues) is prohibited. Licensee shall not include any Licensed Content on Licensee's web site, intranet, or extranet, without prior written permission from EPE, except as permitted pursuant to Section 2.
